The 1st edition was based on several rounds of consultation with over 100 charitable organizations and experts. The 2nd edition of the guidelines was published in 1999. The 2nd edition received support from an expanded group which included service providing organizations (NGOs) in international development and umbrella organizations of the pharmaceutical industry, several United Nations firms and the World Bank. 3rd edition was published in 2011. Changes in this 3rd edition of the guidelines are based on a review of occurrence and comments received through an advising process.
