real life, when a gamer passes away due to illness, accident, or other reasons, whether their gaming virtual account can be inherited to a loved one, or other designated heir is a highly debated issue.

In the context of the Civil Code, the legal research on the inheritance of game virtual accounts has become a hot topic. After several twists and turns, he was able to obtain two notarial deeds from the notary public.

Although this case is not directly about the inheritance of the game's virtual account, it does involve the inheritance of virtual property. In this case, the mobile phone number is considered a virtual property and is recognized by the notary as inheritable. This case provides a certain reference for the inheritance of the game virtual account.

Another related case is a 2006 online game virtual property dispute case. In this case, player Li purchased another player Zhang's account "Dao Dao Dog" in a certain online game and paid the corresponding fee. However, when Li used the account, the account was recovered by Zhang through appeal. Mr. Li filed a lawsuit with the court, demanding that Mr. Zhang bear the liability for breach of contract and compensate for losses. In the end, the court ruled that Zhang lost the lawsuit and compensated Li for the corresponding losses.

This case involves the transaction and inheritance of virtual property. Although the account itself is not a virtual property that can be inherited, this case illustrates that virtual property can be traded and protected by law. This also provides an indirect legal basis for the inheritance of the game's virtual account.

In general, there are not many cases that directly involve the inheritance of virtual accounts in games. However, from the above two cases, it can be seen that with the development of the Internet and the digital economy, the value of virtual property has gradually been recognized and valued by the society. In the future, there may be more cases involving the inheritance of virtual property, and it is necessary for the law to continuously improve the relevant provisions to protect the rights and interests of users and promote the healthy development of the digital economy.

Guide media attention and reporting: Guide the media to pay attention to the issue of game virtual account inheritance, and actively report relevant cases and related legal issues, and increase public attention and awareness of this issue through media dissemination.

Strengthen public participation: Encourage the public to participate in the relevant discussion and decisionmaking process, such as holding forums, soliciting opinions, etc., to listen to their opinions and suggestions, so as to make the legal provisions formulated more practical and participatory to the public.

Through the comprehensive application of the above approaches and methods, the public's understanding of the inheritance of game accounts in the context of the Civil Code can be effectively improved, and the public's recognition and compliance with relevant laws and regulations can be promoted.

10. Summary

At present, there are relatively few legal research results on the inheritance of game virtual accounts in the context of the Civil Code, because the implementation time of the Civil Code is relatively short, and the research and discussion of related legal issues are still in the preliminary stage. However, some of the following results and analyses can be drawn from some studies and academic papers:

Virtual account as a property with economic value: With the emergence and development of game virtual accounts, more and more people have begun to realize that virtual accounts have economic value. Therefore, in the context of the Civil Code, virtual accounts are considered as a form of property with inherited interests and obligations.

Disputes over inheritance rights and inheritance methods: There is also controversy regarding the inheritance rights and inheritance methods of virtual accounts. Some researchers argue that virtual accounts should be explicitly designated by the right holder in the will or property division agreement, while others argue that virtual accounts can be inherited in traditional inheritance methods, such as testamentary succession and statutory succession.

Limitations of judicial practice: At present, judicial practice has relatively little treatment of the inheritance of game virtual accounts, which may lead to certain uncertainties in the application and interpretation of relevant legal provisions. Some judges may exercise discretion on a case-by-case basis, lacking uniform precedents and guidance.

Preventive measures and platform standardization: Some studies have put forward suggestions for preventive measures and platform standardization for the inheritance of virtual accounts. For example, game operators can manage virtual accounts under a real-name system, and establish inheritance rules and service mechanisms to ensure that the rights and interests of game virtual accounts are protected.

The current research of the project team and the above results and analysis are only the current research situation, with the passage of time and further research work, the legal research on the inheritance of game virtual accounts in the context of the Civil Code will be further enriched and deepened.

In the context of the Civil Code, the legal research on the inheritance of virtual game accounts is a complex and important issue. This article analyzes the concept, characteristics, classification, and legal basis for inheritance of game virtual accounts, and draws the following conclusions:

Game virtual account is a form of online virtual property that has characteristics such as virtuality, value, and dependence. In the game, the player's virtual assets such as characters, equipment, and coins constitute an important part of the game's virtual account.

According to the provisions of the Civil Code, natural persons enjoy legal property rights, including virtual property on the internet. Therefore, the inheritance of game virtual accounts should be protected by law. However, due to the special nature of game virtual accounts, their inheritance issues involve some special issues, such as the ownership of accounts, the identification of inheritors, and the realization of inheritance rights.

In the issue of virtual account inheritance in games, it is necessary to clarify the ownership of the account and protect the legitimate rights and interests of players. At the same time, a sound system for identifying heirs should be established to ensure their legal identity. Finally, it is necessary to improve the implementation mechanism of inheritance rights and protect the legitimate rights and interests of heirs.

In order to improve the legal system of virtual account inheritance in games, this article proposes the following suggestions:

Develop specialized regulations for the management of network virtual property, clarify the definition, scope, and rights protection rules of network virtual property. On this basis, special provisions are made for the inheritance of virtual game accounts, clarifying the conditions, procedures, rights and obligations of inheritance.

Establish a network virtual property registration system and implement real name management for game virtual accounts. Through the registration system, the ownership of the account can be clearly defined, avoiding disputes caused by account transfer, loss, and other reasons.

Establish a network virtual property evaluation mechanism to conduct a reasonable evaluation of the value of game virtual accounts. In the evaluation process, factors such as the actual value of virtual assets in the account and market demand should be considered to protect the legitimate rights and interests of the heir.

Strengthen the sense of responsibility of game operators and require them to provide necessary assistance and guidance on the inheritance of virtual game accounts. At the same time, it is necessary to strengthen the supervision of game operators to prevent losses to players caused by improper behavior of operators.

Enhance public awareness and legal awareness of virtual property on the internet. By strengthening publicity and education, players can understand the rights and obligations of game virtual accounts, and use and protect their online virtual assets reasonably.

In summary, in the context of the Civil Code, the legal research on the inheritance of game virtual accounts has important practical significance. By improving relevant laws, regulations, and institutional construction, the legitimate rights and interests of players can be protected, and the healthy development of online games can be promoted. Meanwhile, strengthening regulatory efforts and raising public awareness are also important ways to achieve this goal.
